MEMORANDUM OF UNDERSTANDING between CASE WESTERN RESERVE UNIVERSITY and THAMMASAT UNIVERSITY

Case Western Reserve University, a Tier 1 research university located at 10900 Euclid Avenue, Cleveland, Ohio, 44106, U.S.A. (CWRU), and Thammasat University, a Thailand's second oldest institute of higher education located at 99 Moo 18 Paholyothin Road, Klong Luang, Rangsit, Prathumthani 12121 Thailand (TU) hereby enter into this Memorandum of Understanding (MOU) as of the 17th day of April, 2014. Individually, CWRU and TU shall be referred to as a Party; together CWRU and TU shall be referred to as the Parties.

WHEREAS:

- A. The Parties desire to enhance their international reputations, cooperation and engagement.
- B. The Parties desire to further their institutional missions of education, research and service.
- C. The Parties desire to strengthen and expand their relationship and the mutual contacts.

NOW THEREFORE, the Parties mutually agree as follows:

- 1. The Parties hereby enter into this Memorandum of Understanding in order to work cooperatively together to advance the elements set forth above in A C. The Parties may discuss specific means of collaborating in the following areas:
 - a. Exchange of faculty, staff, and students.
 - b. Joint research projects.
 - c. Joint education and training programs.
 - d. Exchange of academic and research publications and information.
 - e. Collaborative funding and fund development.
 - f. Education, research, training, academic, personnel and other activities and areas, as may be agreed between the Parties.
- 2. This MOU expresses the intention of the Parties. It places no financial obligation or funding commitments on either Party. The terms of each specific activity contemplated under this MOU shall be mutually discussed and agreed to in writing by authorized representatives of both Parties prior to the initiation of such activity.
- 3. Neither Party shall make any public announcement or statement, nor publish or release any information in relation to any proposed activity or proposed collaboration, without the prior written approval of both Parties.
- 4. This MOU will become effective upon the date set forth above and shall remain valid for a period of five (5) years from such date. The MOU may be modified by the mutual written consent of the Parties. Either Party may terminate the MOU by

giving the other Party six (6) months' written notice, unless an earlier termination is mutually agreed.

All official communication between the Parties under this MOU shall be by written 5. notice and shall be sent via email to the other Party at the following email address:
