

**LETTER OF AGREEMENT
BETWEEN

Background History of Faculty of Nursing, Thammasat University

Faculty of Nursing was established on June 28th 1996. It is the fourteenth faculty of Thammasat University. Thammasat University is Thailand's second oldest university. Officially, the university inaugurated on 27 June 1934. Faculty of Nursing follows Thammasat University's guiding philosophy to uphold academic excellence, services to society, promotion of arts and culture, social equality and social justice under the philosophies of constitutional monarchy and democracy.

Students from Thammasat University and also Faculty of Nursing are not only well-rounded and well-adjusted members of their community, but are also conscious of their social responsibility as famously expressed by a former student,

"I love Thammasat because Thammasat teaches me to love the people."

The Faculty's vision is to be a leading institution in producing quality graduates that meet international standards and are outstanding in terms of virtue, morality, and Thammasat characteristics; to be an excellence research center that integrates nursing knowledge and related sciences for the Country's development, academic services, and continuing education.

The primary focus of the educational process is the health of the community. The curriculum is drawn especially for the purpose of promotive, preventive, curative and rehabilitative health care in the ethical setting as well as in the community.

Terms of Agreement

Faculty of Nursing and University of Nursing, Mandalay, wishing to enhance relations between the two institutions and to develop academic and cultural exchange in

the areas of education, research, and other activities, agree to collaborate and work together toward the internationalization of higher education.

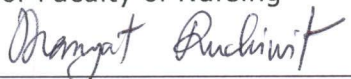
The areas of cooperation will include any program offered by either institution which is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions. However, any specific program shall be subject to mutual consent, availability of funds, and approval of each institution. Such programs may include:

- a. Exchange of students
- b. Exchange of faculty members
- c. Joint research projects
- d. Joint conferences
- e. Joint cultural program

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

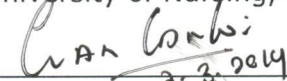
This agreement shall be effective upon approval by both parties and shall remain in effect for an initial period of five years. Thereafter it shall be automatically renewed from year to year; however, after the initial period either institution may terminate the agreement at the end of a given year by giving six months notice in writing of such intent.

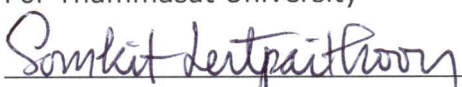
